4. It is resolved that, those who are doing research in their field in respect of faculty members and research scholars advised to use the plagiarism Software from the affiliating university i.e, Y.V University, Kadapa.
5. It is resolved that, the college shall conduct Sensitization seminars/ awareness programs every semester on responsible conduct of research, thesis, dissertation, promotion of academic integrity and ethics in education for students, faculty researchers and staff.
6. It is resolved that, to encourage student and faculty to register on International Registry Systems.
7. It is resolved that, the college shall declare and implement the technology based mechanism, using appropriate Software so as to ensure that the documents such as thesis, publications or any other documents are free of plagiarism at the time of Submission.

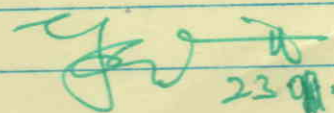

It is resolved that, to create awareness on Similarity Checks for exclusion from plagiarism, levels of the plagiarism, detection/reporting/handling of plagiarism, departmental academic integrity panel, Institutional academic integrity panel, Penalties in case of plagiarism in submission of thesis and research publications and its levels of penalty.

12. It is resolved that each supervisor should submit a certificate indicating that the work done by the researches under him/her is plagiarism free.



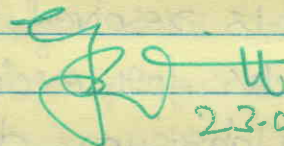

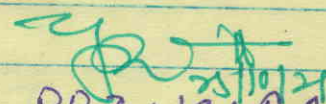
