1. As per the Proceedings of the Vice-Chancellor's reference-3. It is herewith providing the Revised Proceedings of the Principal, by removing Co-Supervisor to the candidate **Mr. S.K. Shahabuddin**. The date of joining is considered as the date one as per the University Proceedings vide reference-2. Hence, his registration has been certified from the date of joining i.e. **10-04-2023**. In continuation with the earlier Proceedings issued by the authorities.
2. The Research Supervisor shall finalize the broad area of research within 45 days and shall get the proceedings regarding the title of the research topic from the principal.
3. The candidate is informed to follow the regulations/ guidelines of PhD. 2018 (Part-Time) and the conditions laid down by the University from time to time scrupulously.
4. The registration of a PhD Scholar may be cancelled by the Principal, YVUC within a stipulated period if the candidate fails to satisfy the conditions specified in the admission order or violates the rules and regulations of PhD after giving notice to the concerned candidate. The principal of YVUC may also cancel the registration of a PhD. Scholar on the recommendation of the Supervisor and /or Department Research Committee i.e., a) where the progress has been reported to be unsatisfactory in two consecutive years/ Research Review Meetings, b) where a candidate discontinues research and/or where the candidate has not submitted the thesis in the stipulated duration of the course and d) where the candidate request for cancellation due to his/her reasons.
5. As per the UGC guidelines PhD, scholars should compulsorily complete Research and Publication Ethics (RPE) course.
6. A Part-Time research student shall be required to be present during the summer vacation of two. Months in a year and shall stay at least four summers in the Department during his/her course Period. After the completion of the fourth summer, the candidate must seek an extension for each Year and pay the fee as per university regulations and guidelines.
